



There were no comments at this time. Carried unanimously.

Moved by Steinlage and seconded by Mueterthies to approve the consent agenda items. Board Minutes: September 14, 2020, regular meeting. Appointments: Stepha nie Sullivan - volunteer assistant volleyball coach and Steve Hoffert - assistant girls basketball coach 20-21 season. Resignations: none. Open Enrollments - approved. Carried unanimously.

Moved by Shatek and seconded by Steinlage to approve the financial reports and bills. General Fund \$40,387.65, Hot Lunch \$8,392.90, Clearing \$13,804.78, PPEL/Capital \$7,865.36. Carried unanimously.

Senior Career Students joined the board meeting and Mr. Pfaffle and FFA students updated the board on FFA happenings. FFA has 46 members. FFA is currently sponsoring fruit sales.

Moved by Steinlage and seconded by Schmitt to approve the following board representatives to the county conference boards: Don Blazek Jr. in Chickasaw Coun ty, Jody Steinlage in Fayette County and Leon Shatek in Winneshiek County. Carried

unanimously. Moved by Shatek and seconded by Mueterthies to keep the school board committees as follows:

1) Negotiations A) Certified - Blazek & Schmitt B) Non-Certified - Shatek & Steinlage; 2) Facilities - Blazek & Schmitt 3) Transportation - Shatek & Steinlage 4) Au dit/Budget - Mueterthies & Shatek. Carried unanimously.

Mr. Jurrens told the board that our teachers and staff have been working hard with extra cleaning, teaching in the classroom and virtually, and keeping up with all of the extra Covid items this year. He would like to implement a 1:15 dismissal on the second Wednesday of each month effective in November 2020. No meetings or professional development would be scheduled. Teachers could use this time in their classrooms as needed. Moved by Schmitt and seconded by Steinlage to approve these early dismissal days as presented. Carried unanimously. Moved by Shatek and seconded by Mueterthies to approve the SBRC Request for Modified Allowable Growth for the district's Special Education Deficit of \$37,693.00. Carried unanimously.

Moved by Shatek and seconded by Schmitt to approve the Turkey Valley Athletic Boosters purchase of a trailer. Carried unanimous

Moved by Schmitt and seconded by Steinlage to increase the adult lunch price from \$3.75 to \$3.85. This increase was recommended by the state. Carried unanimously. Mr. Jurrens also shared with the board that the USDA program will continue providing free breakfast and lunch for all Turkey Valley students through the remainder of the school year.

Moved by Shatek and seconded by Mueterthies to close the public hearing for Continued Participation in the Instructional Support Program @ 7:25 p.m. Carried unanimously. The President declared the hearing closed. Director Ernie Schmitt introduced the following Resolution and moved its adoption. Director Leon Shatek seconded the motion to adopt. The roll was called, and the vote was: Ayes: Don Blazek Jr., Brenda Mueterthies, Ernie Schmitt, Leon Shatek, and Jody Steinlage. Nays: None

The President declared the Resolution adopted as follows: RESOLUTION TO CON-TINUE PARTICIPATION IN THE INSTRUC-TIONAL SUPPORT PROGRAM

WHEREAS, the Board of Directors has determined that to continue the current level of services and to fund the ongoing programs of the School District, continuation of participation in the Instructional Support Program for a period of five years is necessary and in the best interests of the District and its residents and students; and WHEREAS, the Board of Directors has given consideration to continue participation in the Instructional Support Program as provided in Sections 257.18 through 257.21, Code of Iowa; and WHEREAS, the Board has published notice of the time and place of a public hearing on the Resolution; and WHEREAS, a hearing has been held upon the proposal to continue participation in the Instructional Support Program and any objections are overruled: NOW, THEREFÓRE, IT IS RESOLVED:

1. The Board of Directors determines that it is consistent with the five-year finance plan to fund the ongoing programs and services of the School District and it is in the best interest of the School District to continue participation in an Instructional Support Program as provided in Sections 257.18 through 257.21, Code of Iowa, and to provide additional funding therefor for a period of five (5) years commencing with the fiscal year ending June 30, 2022.

2. The additional funding for the Instructional Support Program for a budget year will be determined annually and will not exceed ten percent (10%) of the total regular program district cost for the budget year and monies received under Section 257.14, Code of lowa, as a budget adjustment for the bud get year.

3. Moneys received by the District for the Instructional Support Program may be used

for any general fund purpose. 4. The Instructional Support Program will be funded by instructional support state aid and an instructional support property tax levied annually upon the taxable property within the School District

5. Unless, within twenty-eight days fol-

lowing the adoption of this Resolution, the Secretary of the Board receives a petition containing the signatures of eligible electors equal in number to not less than one hundred or thirty percent of the number of voters at the last preceding regular school election, whichever is greater, asking that an election be called to approve or disapprove this acion of the Board adopting the Instructional Support Program, this action of the Board is final and the Secretary is authorized and directed to certify a copy of this Resolution to the Department of Management.

In the event a petition containing the required number of signatures is filed with the Secretary of the Board within twenty-eight days of the adoption of this Resolution, the President shall call a meeting of the Board o consider rescission of this Resolution, or to direct the county commissioner of elections to submit the following question to the qualified electors of the School District at a special election.

If the Board determines to submit the question to the electors, the proposition to be submitted shall be as follows:

Shall the Board of Directors of the Turkey Valley Community School District, in the Counties of Chickasaw, Howard, Fayette, and Winneshiek, State of Iowa, be authorized for a period of five (5) years to levy annually, as determined by the Board, an instructional support property tax in an amount (after taking into consideration instructional support state aid) not to exceed ten percent (10%) of the total of regular program district cost for the budget year and moneys re-ceived under Section 257.14, Code of Iowa, as a budget adjustment in the budget year, to be levied upon the taxable property with-in the School District, commencing with the levy for collection in the fiscal year ending June 30, 2022, to be used for any general fund purpose? PASSED AND APPROVED this 12th day of October, 2020.

Mrs. Cuvelier shared that even with the Covid restrictions, the Homecoming festiviies went well. Staff are participating in the 5-2-1-0 wellness program. The staff continues to attend inservices and professional development. Mr. Blazek thanked Mrs. Cuvelier for allowing parking at her home during the cross country meet.

Mr. Jurrens told the board that our enrollment is down this year but that is in part because of a large senior class who graduated in 2020. He also told the board that Turkey Valley is in great shape financially and that we will be serving students for a long time. He also shared information from the auditors. Thanks to Janice Myers for all of her hard work on the audit and the CAR. Her efforts are greatly appreciated. The convention is virtual this year. Turkey Valley will ask all staff and students not to use the gaiter masks per recommendations from public health. The fall sports will be starting their post season play soon. Good luck! Mr. Jurrens told the board that he has had some questions on early retirement and health insurance for para educators. He will share additional information with the board mem-

bers at a later date. The board would also like to thank Ms. Myers and Mr. Jurrens for their work with the audit and the CAR. Thanks to FFA for shirts for board members. Thank you to the Local egions for presenting colors at our home football games.
