ORDINANCE AMENDING THE COUNTY ZONING ORDINANCE WITH THE ADDITION OF RENEWABLE ENERGY SECTIONS 714 & 715 AND COMPATIBILITY CHANGES TO 404.90, 702.13 AND AN UPDATE OF THE CONDITIONAL USE CHART.

WHEREAS, the Planning and Zoning Commission have determined that further regulation is required for future renewable energy development

WHEREAS, the Planning and Zoning Commission have held a public hearing on the proposed amendment.

WHEREAS, a notice of the time and place of a public hearing on said request was published pursuant to law; and

WHEREAS, the Winneshiek County Board of Supervisors has considered the Winneshiek County Comprehensive Plan in their review of the proposed amendment and find that the request is consistent with the policies and goals set

out in the Winneshiek County Comprehensive Plan; and,

WHEREAS, a public hearing, as required, has been conducted by the Winneshiek County Board of Supervisors.

NOW, THEREFORE, BE IT ORDAINED BY THE WINNESHIEK COUNTY BOARD OF SUPERVISORS:

That sections 714 and 715 are now added to the Winneshiek County Zoning Ordinance V.

That changes to 404.90, 702.13 and the updated Conditional Use Chart have been made to the Winneshiek County Zoning Ordinance V.

That the official copies of the zoning ordinances of Winneshiek County, Iowa, be modified to reflect this change.

Repealer. All ordinances or parts of ordinances in conflict with this zoning ordinance or inconsistent with the provisions of this Ordinance, are hereby repealed to the extent necessary to give this Ordinance full force and effect.

Severability Clause. If any section, part or provision of this Ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the Ordinance as a whole, or any section, provision or part thereof not adjudged invalid or unconstitutional.

Effective Date. This Ordinance shall be in full force and effect after its passage and publication as provided by law.

ORDINANCE AMENDING THE COUNTY ZONING ORDINANCE TO CHANGE THE ZONING CLASSIFICATION FROM A-1 AGRICULTURAL DISTRICT TO A-R AGRICULTURAL RESIDENTIAL DISTRICT FOR THE HEREIN DESCRIBED PROPERTY.

is hereby changed from A-1 Agricultural District to A-R Agricultural Residential District.

ORDINANCE AMENDING THE COUNTY ZONING ORDINANCE CHANGING THE PLANNING AND ZONING COMMISSION TO SEVEN MEMBERS.

WHEREAS, the Planning and Zoning Commission have held a public hearing on the proposed amendment.

WHEREAS, a notice of the time and place of a public hearing on said request was published pursuant to law; and,

WHEREAS, the Winneshiek County Board of Supervisors has considered the Winneshiek County Comprehensive Plan in their review of the proposed amendment and find that the request is consistent with the policies and goals set out in the Winneshiek County Comprehensive Plan; and,

WHEREAS, a public hearing, as required, has been conducted by the Winneshiek County Board of Supervisors.

NOW, THEREFORE, BE IT ORDAINED BY THE WINNESHIEK COUNTY BOARD OF SUPERVISORS:

That paragraph 502.3 of Zoning Ordinance V, as amended will now

read:

"The Planning and Zoning Commission shall consist of seven (7) members appointed by the Winneshiek County Board of Supervisors. An effort shall be made to keep Commission membership geographically balanced. The term of appointment shall be five (5) years. Any vacancy shall be filled in the same manner for the unexpired portion of the term. In the event of the absence from the County or in the incapacity of a member, the Board of Supervisors may appoint a substitute who shall serve as a member of the Commission, with the same powers and authority as the regular member, until such regular member has returned."

That paragraph 502.9 of Zoning Ordinance V, as amended will now read:

"The presence of four (4) Commission members shall be necessary to constitute a quorum. The concurring vote of the four (4) members shall be necessary on all matters upon which it is required to pass under the provisions of this Ordinance."

That the official copies of the zoning ordinances of Winneshiek

County, Iowa, be modified to reflect this change.

Repealer. All ordinances or parts of ordinances in conflict with this zoning ordinance or inconsistent with the provisions of this Ordinance, are hereby repealed to the extent necessary to give this Ordinance full force and effect.

Severability Clause. If any section, part or provision of this Ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the Ordinance as a whole, or any section, provision or part thereof not adjudged invalid or unconstitutional.

Effective Date. This Ordinance shall be in full force and effect after its passage and publication as provided by law.

Krista Vanden Brink, Public Health Administrator, met with the Board to discuss COVID19 updates.

Moved by Kuhn and seconded by Ashbacher to adopt resolution 21-42, approving the appointment of Makenz Allen Kriener as Deputy Sheriff. Motion carried unanimously by roll call vote.

Moved by Kuhn and seconded by Thompson to open the public hearing on the proposed Zoning Ordinance Amendment to change the number of members on the Planning and Zoning Commission. Motion carried unanimously by roll call vote. Tony Phillips, P&Z Administrator, reviewed the proposal and reported the P&Z Commission held a public hearing and unanimously recommended approval. The Board responded to one comment received, and received no

additional comments. Moved by Thompson and seconded by Ashbacher to close the public hearing. Motion carried unanimously by roll call vote. Moved by Thompson and seconded by Kuhn to hold the reading of the proposed amendment. Motion carried unanimously and the reading was held. The Turkey Valley School Board met in a regular session on Monday, November 9, 2020. The meeting was held in the Elementary Media Center at Turkey Valley School, Jackson Junction, IA. Don Blazek, Jr. called the meeting to order at 7:00 PM. The following Board Directors answered roll call: Jody Steinlage, Leon Shatek, Don Blazek Jr. and Ernie Schmitt. Brenda Mueterthies was absent.

Moved by Shatek and seconded by Steinlage to approve the agenda as presented. Carried unanimously.

Moved by Schmitt and seconded by Shatek to approve the consent agenda items. Board Minutes: October 12, 2020, regular meeting. Appointments: volunteer boys basketball coaches 20-21- John Izer and Levi Izer; volunteer girls basketball coach 20-21 - Justin Bakula; 7&8 wrestling coach - Clint Rodgers; and paraeducator - Ellen McConnell. Resignations - none. Open Enrollments - none. Carried unanimously.

Moved by Shatek and seconded by Steinlage to approve the financial reports and bills. General Fund \$40,465.46, Hot Lunch \$10,885.63, Clearing \$19,112.22, PPEL/Capital \$28,482.03. Carried unanimously.

Mrs. Milbrandt informed the board that Senior Careers looks a little different this year. They are doing some job shadows by zoom and they will do mock interviews by zoom as well. The annual Veterans Day celebration will be held but will look very different this year. Thanks to all who organized and worked on this event.

Moved by Shatek and seconded by Schmitt to approve the early graduation request for Isabella Langreck pending the completion of all her classes and credit requirements. Carried unanimously.

Moved by Schmitt and seconded by Shatek to approve the SBRC request for Modified Supplemental Amount for ELL, \$9,497.00 and Open Enrollment Out Spending Authority, \$63,984.00. The total request is \$73,481. This is not a request for funds, but for spending authority. Carried unanimously.

The board has been asked to consider providing health insurance for associates. Since most associates are special education, the general fund won't be affected but the impact will be to the property taxes. The associate representatives stated that if health insurance were provided, it would help Turkey Valley maintain the great staff it currently has and for future hirings, more quality applicants would be interested. Associates are an integral part of the staff at Turkey Valley. The board and the associate staff still had some questions. Mr. Jurens will bring these answers and additional information to the next board meeting. Moved by Shatek and seconded by Schmitt to table this item until the next regular meeting. Carried unanimously.

Mr. Jurens shared the UIC Superintendent's letter with the board. It states that there will be a mask mandate for attendance at all conference activities. Moved by Shatek and seconded by Schmitt to implement the following phases for activity guidelines: Phase 1: Start as normal, if masks are not being worn, move to Phase 2. Phase 2: Limit fans to 50% of gym capacity. A limited number of "tickets" for each athlete will be handed out. If mask mandate is still not adhered to, move to Phase 3. Phase 3 - no fans at events. Carried unanimously. Although the mask mandate is conference wide, each school may be at a different "phase" within its building. The board asked "how will our patrons know which school is allowing attendance or who has a no fan rule?" This information will be shared via social media as Turkey Valley receives it.

Mr. Jurens shared notes from Mrs. Cuveller that parent teacher conferences were held virtually this year and that they went well. We are currently revamping the breakfast/lunch plan so that all students can socially distance while eating. Mr. Jurens stated that Mrs. Cuveller has been doing a great job. There are many things to learn and a Covid year makes it even more challenging.

Mr. Blazek thanked the staff for all of their hard work. They have been remarkable in working through all of the updates and revisions to make us compliant and most importantly keep the staff and students safe. Keep up the good work.

14, 2020 @ 7:00 PM.

Moved by Schmitt and seconded by Steinlage to adjourn at 7:50 PM. Carried unanimously.

ORDINANCE AMENDING THE COUNTY ZONING ORDINANCE CHANGING THE PLANNING AND ZONING COMMISSION TO SEVEN MEMBERS.

WHEREAS, the Planning and Zoning Commission have held a public hearing on the proposed amendment.

WHEREAS, a notice of the time and place of a public hearing on said request was published pursuant to law; and,

WHEREAS, the Winneshiek County Board of Supervisors has considered the Winneshiek County Comprehensive Plan in their review of the proposed amendment and find that the request is consistent with the policies and goals set out in the Winneshiek County Comprehensive Plan; and,

WHEREAS, a public hearing, as required, has been conducted by the Winneshiek County Board of Supervisors.

NOW, THEREFORE, BE IT ORDAINED BY THE WINNESHIEK COUNTY BOARD OF SUPERVISORS:

That paragraph 502.3 of Zoning Ordinance V, as amended will now

read:

"The Planning and Zoning Commission shall consist of seven (7) members appointed by the Winneshiek County Board of Supervisors. An effort shall be made to keep Commission membership geographically balanced. The term of appointment shall be five (5) years. Any vacancy shall be filled in the same manner for the unexpired portion of the term. In the event of the absence from the County or in the incapacity of a member, the Board of Supervisors may appoint a substitute who shall serve as a member of the Commission, with the same powers and authority as the regular member, until such regular member has returned."

That paragraph 502.9 of Zoning Ordinance V, as amended will now read:

"The presence of four (4) Commission members shall be necessary to constitute a quorum. The concurring vote of the four (4) members shall be necessary on all matters upon which it is required to pass under the provisions of this Ordinance."

That the official copies of the zoning ordinances of Winneshiek

County, Iowa, be modified to reflect this change.

Repealer. All ordinances or parts of ordinances in conflict with this zoning ordinance or inconsistent with the provisions of this Ordinance, are hereby repealed to the extent necessary to give this Ordinance full force and effect.

Severability Clause. If any section, part or provision of this Ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the Ordinance as a whole, or any section, provision or part thereof not adjudged invalid or unconstitutional.

Effective Date. This Ordinance shall be in full force and effect after its passage and publication as provided by law.
